

Terms and Conditions:

1. In this campaign, unless the context otherwise provided, the following words are defined as follows:
 - a. The Promoter is Campus Living Villages Pty Limited ABN 093 198 915 19 (phone: 02 9270 1600) ("CLV").
 - b. AWST means Australian Western Standard Time.
2. Refer to Table 1 below for particulars of the campaign, subject to the terms and conditions below.

3. The campaign will begin at 9:00am AWST 31st August 2011.
4. A Current Resident is a resident currently residing at Murdoch University Village for 2011 and will, by the Contract Submit Date for the applicable Prize Category, have submitted to the Promoter a signed 42-week residential agreement for 2012 and all associated documents, and will be entitled to enter into the draw to win Option A or Option B of that Prize Category.

5. A New Resident is an applicant who will, by the Contract Submit Date for the applicable Prize Category, have submitted to the Promoter a signed 42-week residential agreement for 2012 and all associated documents, and will be entitled to enter into the draw to win Option A or Option B of that Prize Category.
6. There will be:
 - a. one winner for Prize Category 1;
 - b. one winner for Prize Category 2; and
 - c. a total of 10 winners for Prize Category 3.
7. In respect of Prize Category 1 Option B and Prize Category 2 Option B, the Rent Rebate will be applied as follows:
 - a. on or about the commencement of Semester 2 2012 (i.e. 2 July 2012), the Promoter shall apply the applicable Rent Rebate as a credit to the winners' account held at Murdoch University Village;
 - b. the Rent Rebate will be applied as a credit towards the residential fee and utility fee payable under the winners' residential agreement; and
 - c. for the avoidance of doubt, the winners must continue to pay the residential fees in accordance with the winners' residential agreement.
8. In respect of Prize Category 3, the Internet Access Card means a pre-paid BigAir internet service plan card provided by the Promoter pursuant to this campaign to the winners, on the following basis:
 - a. the Internet Access Card to be valid for a period of five calendar months from the date of first activation (**Expiry Date**);
 - b. the Internet Access Card will have a capped data limit of 10GB (**Data Limit**). Once the Data Limit is reached, the internet connection speed will be reduced from 2Mbps/256kbps to 64kbps;
 - c. the Internet Access Card will expire on the first to occur of:
 1. the Expiry Date; or
 2. the Data Limit being reached.
 - d. the winners shall be entitled to a maximum of one Internet Access Card each; and
 - e. once the winners are notified by the Promoter, the Internet Access Cards shall be available from reception for collection.
9. The Promoter shall notify the winner(s) of each Prize Category within seven days from the Prize Draw Date.
10. Once the Promoter has notified the winner of the relevant Prize Category, the winner may elect to receive Option A or Option B (where applicable) of that Prize Category by notifying the Promoter.
11. The awarding of the prizes to the winners of the draws is subject to and conditional upon the winner having paid the security deposit and first two (2) weeks of residential fees pursuant to their 42-week residential agreement for 2012 with Murdoch University Village.
